The first record there is the 1790 Federal Census, Morgan's 16th Co. District in Wilkes Co. which was formed in 1777 and from which Ashe Co. was taken in 1799. From the registrar of Deeds at Wilkesboro, Wilkes Co. it is learned that his first land purchase was in 1796. Clayton Miller of Sparta N.C. (1963 letter, he is not a descendant of this family) says his land was in what seemed to be a Dunker settlement. The registrar of Deeds at Jefferson, Ashe Co. shows his last purchase was made in 1808 and in 1811 in one transaction sold all of his holdings, 490% acres including the 1796 purchase. Land records in Montgomery Co., Oh. have not been searched. He is said to have been a Dunker minister, but this may be only family tradition. No record is found in Montgomery Co. of his being a minister at weddings. His prime interest was farming in connection with wagon-making. He with his eldest son are said to have constructed the first windmill in Montgomery Co. Joseph and Mary's tombstones are located in a field near Martindale Rd. between St. Rt. 48 and Frederick Pike, section 11 in Butler twp. and are very legible. These are the only two markers now found there, but family tradition states that the emigrant father Ulrich is also buried there. The area is now part of the Miami Conservancy District.

The following is family tradition written by the late Dr. William H. H. Kessler of West Milton, Oh. The family emigrated from Switzerland (ship and date not established). The mother died at sea, leaving her husband, a son and a daughter. Upon arrival each were sold into servitude to pay for the passage. Ulrich, the son was about 11 years of age at that time, having been born circa 1740. He was bound out to an Amish or Mennonite family where he learned weaving. At the end of his service, he searched unsucessfully for his father and sister. He returned to the neighborhood of his former home near Philadelphia and there married (wife's name unknown) becoming the father of Joseph K., John, Henry, Daniel or David and a daughter who did not long survive. He accumulated \$53,240 Continental money through his thrift and industry at the loom, which he was swindled out of in Pa. His wife and son Henry died in Pa. and the father with the remaining sons moved to Va. (county unknown) for a short time and from there to Wilkes Co., N.C. in the area that later became

Ashe Co. He is listed in the 1790 Federal Censu as Olwich Kisler with three sons under 16 (indicating the previous listing of children may not include all of his sons). About 1811, he and his sons traveled northward due to the fact that taxation in N.C. had become prohibitive. Son Daniel or David stopped off in Southern Ky. (Bowling Green area?) where he raised his family. Ulrich with sons Joseph K. and John continued on to Montgomery Co., Oh. Dr. William H. H. Kessler 1839-1914 eldest child of Martin Kessler 1816-1863 & Anna Hoover 5th child of John Bowman Kessler 1787-1866

John Kessler, b. 9 Jul 1768, d. 8 Feb 1845 Kosciusko Co., In. may be a son of Ulrich. The Biographical and Historical Record of Kosciusko County, Indiana, 1887, Lewis Publishing Co., p.p. 248, 317 contain biographical sketches of Dr. Benjamin and his brother Elias, sons of Nathaniel and Elizabeth (Kissler) Burkett (Burket per their tombstones). The sketches state that $El\overline{i}z$ abeth was a d/o John & Mary (Custer) Kissler. A Dunker family, their 1st child was born in 1809 in Rowan Co., N. $\overline{\mathbb{C}}$., their 3rd in Hamilton Co., Oh. 1812, 4th in Montgomery Co., Oh. in 1814, 11th in Jefferson twp., Wayne Co., In. from which they moved to Miami Co., In. and in 1850 to Franklin twp., Kosciusko Co., In. where they are buried in the Nichols Ceme. Elizabeth, b. 15 Mar 1792 N.C., d. 25 Apr 1858; Nathaniel, b. 27 Aug 1784 Rowan Co. (now Davidson Co.), N.C., d. 3 Oct 1863 s/o Elder Jehu & Magdalene (Croll) Burkhard.

Margaret (Whiteneck), d. 2 Apr 18(80?) @ 67y11m9d; m. Nov 1849 Grant Co., In. as his 2nd wife; his Will filed Fulton Co., In.; a known LI WEL; son of John; known to have lived in Miami Co., Oh., Henry, Delaware, Randolph, Jay (likely), Grant (likely) and Fulton Co.'s, In. Another son may have been John Kessler who died in Labette Co., Ks. in 1874. He m. in Henry Co., In. Mary (Anderson) Cates who d. 7 Feb 1888 @ 78y8m13d and is buried in the same row with the rest in Nichols Ceme. Further investigation into this family relationship may reveal that indeed this is the brother of Joseph K. Kessler.

Ulrich Kessler did not buy land in Montgomery Co., Oh. nor did he leave a Will and no estate was filed for probate, presenting a difficult situation in proving who his children actually were. this point, we only have the family traditions to fall back on.
